## Thursday May 14th, 2020 – Coronavirus Update **Please note anything highlighted in turquoise is new information**

### Goal 1: Keep employees healthy and safe

#### A. Total Number of PPE and Test Supply Available Per Site: All sites are in need to gowns

- i. Dental-Sedalia:
  1. 23 day supply of PPE
- ii. Dental-Warsaw:
  1. 21 day supply of PPE
- iii. Marshall:
  1. 35 day supply of PPE
  2. Quest Test: 4
  3. LabCorp Test: 4
  4. GeneTrait Kits: 60
- iv. Sedalia:
  1. 92 day supply of PPE
  2. Quest Test: 9
  3. LabCorp Test: 2
  4. GeneTrait Kits: 67
- v. Versailles:
  1. 33 day supply of PPE
  2. Quest Test: 13
  3. LabCorp Test: 6
  4. GeneTrait Test: 7
- vi. Warsaw:
  1. 59 day supply of PPE
  2. Quest Test: 0
  3. LabCorp Test: 9
  4. GeneTrait Kits: 20

B. Expect to receive additional PPE this week. Today we received another 3 boxes of face shields.

C. Our Nursing Educator will be supplying all clinics with laminated PPE posters. When you are unsure what PPE to do you can reference these posters. They will be delivered to all clinics on Monday and spread throughout the clinic. Keep an eye out for them!

### Goal 2: Keep possible COVID-19 patients from spreading illness to the community

- A. When calling patients regarding negative COVID-19 test results. Please address if there symptoms are getting better, the same, or worsening. If patient states there symptoms are the same or getting worse please notify the provider and an appointment may be needed.
  - a. COVID-19 test sensitivity is not 100%. It is important to address their symptoms and determine if further action is needed.

**Goal 3: Continue to provide high quality of care to our patients and our communities patients by using science to guide prevention, testing, and treatment**

- A. Hours for Community Testing:
  - a. Sedalia: Monday – Friday 9 a.m. to 12 p.m.
  - b. Warsaw: Tuesday and Thursday 9 a.m. to 11 a.m.
  - c. Versailles: Monday – Friday 8 a.m. to 10 a.m.
  - d. Marshall: Monday, Tuesday, and Friday 10 a.m. to 12 p.m.
- B. Number of patients seen today during the community testing hours:
  - a. Marshal: No Community Testing Today
  - b. Sedalia: 23 individuals tested
  - c. Versailles: 1 individuals tested
  - d. Warsaw: 16 individuals tested
- C. Katy Trail tested 52 residents at a local nursing home today!
- D. COVID-19 Test Work Note: For those individuals that request a work note after being tested for COVID-19, please extend the note for 5 day and state “or until test results are confirmed.”

**Goal 4: Contribute to the community efforts to address the crisis**

- A. Handing out food boxes to Katy Trail patients that we test for COVID-19 and are quarantined
- B. Participating daily in the Incident Command Meeting

**Goal 5: Assure our financial security in order to sustain our services**

- A. Small Business Loan – Katy Trail has been approved.
- B. Applied for the FCC telehealth grant
- C. Received CARES Emergency funds
- D. KTCH is billing for both telehealth and telephone visits

**Goal 6: Plan for the new future of KTCH**

- A. Continuing with EHR implementation. Expected go-live date with ECW will be October 1<sup>st</sup>.
- B. Population Health approach to virtual visits – Working on a process.
  - a. Currently, case managers are reaching out to high-risk patients that need a follow up appointment and to ensure they have the resources they need. Also, there are two active PDSA’s that were put into place. One PDSA is reaching out to patients that are due for a colon cancer screening. Staff are delivering a goodie bag that contains a roll of toilet paper and a FIT Test. What better time to capture these patients while they are in the comfort of their home! The second PDSA is reaching out to our uncontrolled hypertension patients. For those that have uncontrolled hypertension and need to be monitored more closely, staff are delivering blood pressure cuffs to their home.

**Oral Health Update from Dr. Vandevender and Mendy:**

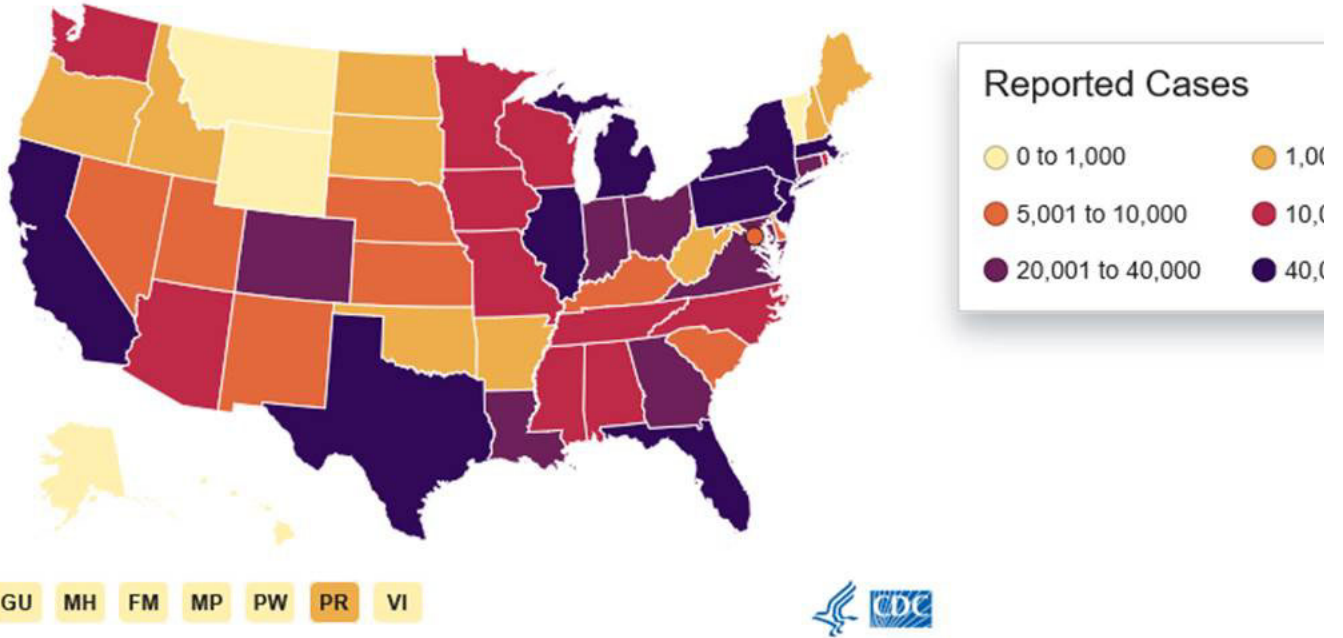
- A. Starting Monday the 18<sup>th</sup> oral health will increase from 4 to 6 encounters a day. Scheduling will remain the same as the earliest open appointment will be filled first.

- 1. **Cases Reported in U.S.**
  - a. As of today, there has been a total of 1,384,930 COVID-19 cases in the United States. Please see map below of states reporting COVID-19 cases.
- 2. **In Missouri:**

- a. 10,317 positive COVID-19 cases
  - i. Benton County – 9 positive case
  - ii. Morgan County – 7 positive case
  - iii. Pettis County – 70 positive case
  - iv. Saline County – 224 positive case
